

ALCOHOL/DRUG EVALUATIONS BY LICENSED PROVIDERS

You have been arrested for the offense of Driving Under the Influence of Alcohol or Drugs. Before the court can dispose of your case after a plea of guilty or a finding of guilty, or before the court can consider a petition for judicial driving permit, the law requires you to obtain an Alcohol/Drug evaluation by a licensed provider. Therefore, you are recommended to obtain an evaluation immediately. The following providers are licensed to provide this evaluation in the Fourteenth Judicial Circuit area.
